a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

All staff who are involved in the sale of alcohol shall be trained to operate in accordance with the licensing laws. A written record of the training shall be maintained and shall be available for inspection by an authorised officer following reasonable request.

b) The prevention of crime and disorder

CCTV: A CCTV system shall be installed at the premises and shall meet the following criteria:

- a) The recording shall include the time and date it was made;
- b) The system shall record activities whenever the premises is open to the public;
- c) Recordings shall be retained for at least 30 days after they are made. They shall be made available to an authorised officer on request, as long as such request complies with data protection laws.
- d) The minimum personal data recorded by the system shall be an image of the head and shoulders of any person entering the premises by the main entrance;
- e) 'CCTV In Use' signs shall be displayed in conspicuous positions.

c) Public safety

An incident book to be kept, recording refusals to serve alcohol, age related incidents and anything else that may undermine the licensing objectives. The logbook shall be kept available for inspection by an authorised officer following reasonable request.

d) The prevention of public nuisance

e) The protection of children from harm

A 'Challenge 25' policy shall be adopted and enforced at the premises.

Proof of identity and age shall only be accepted if supported by the production of either; Valid passport; UK photo card driving licence; Official ID card issued by HM Forces, or EU, bearing a photograph and date of birth of the holder; Any other form of identification that is agreed with Cumbria Constabulary

All staff involved in the sale of alcohol shall be trained in relation to the 'Challenge 25' policy upon commencement of their employment. Refresher training shall be undertaken at intervals thereafter.


