## Typical Reasons for Moving into Sheltered Housing

- Aged 60 or over
- Your home is too large or difficult to manage
- You may be wishing to move nearer to friends, relatives or amenities
- A good quality home that is easy to manage
- More security
- Someone on hand if you need them

## What is Sheltered Housing?

Sheltered Housing enables older people to live independently in flats or bungalows within a supportive environment designed to suit their needs. In the Lancaster and Morecambe district, these groups of flats or bungalows are usually called schemes. Although each



scheme is different, they all have 24 hour emergency assistance from locally based staff and most have a communal lounge for informal and organised activities. Some schemes are groups of flats all under one roof and some provide laundry and guest room facilities.

#### **Sheltered Housing Offers:**

- Accommodation that is easy to manage
- A safe and secure environment
- An emergency call system with someone on hand when needed
- Independent living but where care and support can be arranged if you need it.

#### Is Sheltered Housing like a Residential Home?

No. Sheltered Housing is for people who can live independently. The Scheme Manager does not provide nursing or other personal care such as help with dressing or bathing. If you need help of this kind, we will be able to help you to apply for assistance through Lancashire County Council Social Services department. The Scheme Manager is there to check on your welfare and provide support where required.

We have 16 sheltered housing schemes, listed below. Those marked with an \* are designated blocks with extra care forming a part of the scheme. The number in brackets is the number of homes in each scheme.

We can also nominate to sheltered housing schemes owned by housing associations.

#### How do I apply for sheltered housing?

All our sheltered and retirement housing is let through Ideal Choice Homes, our choice based lettings service for the Lancaster district. Through this service we advertise all our current vacancies and you are able to express your interest in the ones that interest you.

To participate in the Ideal Choice Homes letting service you will need to join the Housing Register. To do this you will need to meet certain eligibility criteria and complete an application.

If you need help with applying to join the housing register you can ask for an interview with a Housing Options Officer. At the interview, the officer can help you to complete your application, provide information and advice, and gather any additional information that they need.

It is important if you are applying for Sheltered Housing that you include the following information to allow us to assess your application more fully:

- Medical information.
- Details of any care packages in place.
- Specific accommodation requirements for example, needing level access because you use a wheelchair.

Various other Registered Providers of Social Housing advertise their vacant accommodation through Ideal Choice Homes, although some of these landlords will also maintain their own waiting list for available properties.

#### What is Extra Care Sheltered Housing?

Extra Care Sheltered Housing offers older people an alternative to residential care within a community based setting and aims to maximise independence. It aims to give older people with high levels of care needs the opportunity to remain at home within one of the designated sheltered housing schemes. The care provided is flexible to the needs of the individual. Potential tenants for extra care vacancies are nominated by Lancashire County Council (Social Services). There is a further leaflet available regarding Extra Care.

#### Applying for Extra Care Sheltered Housing

Potential tenants for Extra Care vacancies are nominated by Lancashire County Council (Social Services). If you feel that you need Extra Care sheltered housing rather than general sheltered housing, you will need to speak to Social Services.
