Scope of the Climate Emergency Review of the Local Plan

Lancaster City Council response to Point 3

In September 2020, the council ran an 8-week scoping stage consultation (25th September – 20th November 2020) to help determine the extent of the scope of the Climate Emergency Local Plan Review (CELPR). As part of this consultation, the council produced a list of policies that they considered could potentially be amended or re-visited as part of the CELPR. The document which set these policies out (including a description of each and how it related to climate change mitigation and/ or adaptation): **P_25**: *Policies considered for an update for the adopted DPDs.*

To provide clarity for respondents, a series of topic-based videos were produced to explain why the review was being undertaken and making clear that the scope of the review was specifically about mitigating and adapting to climate change. The written scripts were published on the website.

The videos and scripts covered the topics of

- **SC010**: <u>Launch of the Local Plan Video</u> (overall scope)
- SC014a: <u>Heritage and Climate Change Video</u>
 - **SC014b**: Script Heritage & Climate Change
- SC015a: <u>Energy efficiency in New Housing Video</u>
 SC015b: Script Energy Efficiency in New Housing
- SC016a: <u>Blue-Green Infrastructure (the natural Environment) Video</u>
 - **SC016b**: Script Blue-Green Infrastructure (the natural environment)
- SC017a: <u>Sustainable Transport Video</u>
 - **SC017b:** Script Sustainable Transport
 - SC018a: <u>Water Management Video</u>
 - **SC018b:** Script Water Management

The **SC010**: *Launch of the Local Plan Video* in particular, made clear that the review was not a whole review of the adopted Local Plan, nor a new plan. It made clear that it was a prompt, partial review to explore if the council could do more to reduce emissions and plan development and see if it can be more resilient to the continuingly worsening impacts of climate change.

Throughout the preparation of the partial plan, it has repeatedly been made clear through the online videos and material on the website that the council would not be revising the Local Plan development requirements or the Land Allocations.

The process of undertaking the CELPR was formally commenced by a decision of the Councils' Cabinet on 15th September 2020.

Document **P_25**, discussed above, defined the narrow scope from the outset of the CELPR.

The council sought views on this list and the extent of the scope during this 8week public consultation using the following methods:

Consultation Online Response Form (Questions) **[SC002a]**, (which was also made available in hard copy).

Question 5 of this form in particular sets out a list of policies in the adopted Local Plan that we intended to revisit as part of this climate change review and asked which policies were considered to be most effective in tackling climate change.

The questionnaire was also accompanied by a *Guidance Note* **[SC003]** as well as a *Consultation Booklet* **[SC001]** giving detailed background to the proposed review process.

This was also published extensively [SC004, 5, 6, 7, 11, 13, 20 to 24]

A <u>CELPR launch event</u> **[SC001b]** included a duty-to-co-operate partner engagement session which was held on 1st October 2020, where again Officers set out the clearly defined scope of the review that it intended to follow.

Whilst the tables above present a list of policies that the council considered at the scoping consultation, the table below sets out the policies that have been amended, based on representations made at Regulation 18 consultations, (as can be seen in the submission version of the CELPR (Reg. 22)) [SD_01.1 & SD_01.2].

Parameters within which representations could be made on the CELPR

• Scoping Consultation & Engagement – September to November 2020

As set out above the council sought views on the scope of the CELPR in that it would relate only to policies where climate change impacts could be mitigated or adapted to. The <u>storyboard / webpage</u> **[SC001b]** set out that the council were welcoming comments and participation as to the scope of the reviewed plan and provided an explanation on why consultation is taking place. In addition, the following information was also provided to explain the scope of the CELPR:

- Consultation Booklet [SC001],
- Online Response Form (Questions) [SC002a], and Guidance Note [SC003]
- List of policies that we intend to review [SC002b] and
- FAQ [SC008]

On this storyboard/webpage there was also a link to a series of frequently asked questions in relation to the Local Plan, in terms of both how it has been prepared and what will happen next. More details can be found <u>here</u>, (scroll to the drop-down tab via this FAQ link). The FAQ included the following:

What will the scope of the Local Plan review be?

The scope of the Local Plan Review will be limited. The review will focus specifically on matters around Climate Change only. This means that the council will not be reviewing the allocations made in the Local Plan through this process nor will they be reviewing the development requirements set within the Plan (i.e. there will be no review of the housing requirement targets).

The expectation of keeping tightly defined boundaries is that the Review can take place quickly and an updated plan can be produced which can start to address adaption / mitigation to Climate Change as soon as possible. Opening the Review to a wide range of topics, some of which are highly controversial, will simply slow the process down and mean it will take a lot longer for the Local Plan to be updated in the context of Climate Change.

As previously set out, a <u>*CELPR launch event*</u> [within **SC001b**] was held on 1^{st} October 2020 where Officers set out the clearly defined scope of the review that it intended to follow.

• Regulation 18 stage (July to September 2022)

A report to the City Council's Cabinet on 13th July sought approval for the publication of the CELPR under Regulation 18. The report set out at para 2.3 that importantly the scoping stage sought to clarify and confirm that the CELPR is a Partial Review of the Local Plan, with the express objective of seeking better development outcomes for climate change mitigation and adaption in recognition of the council's Climate Emergency Declaration of January 2019. Para 2.4 goes on to states that the CELPR does not revisit the amount of development required to meet the needs of the community or economy, nor does it re-visit specific land allocations made within the adopted Local Plan. These strategic matters were not easily established during the preparation of the adopted Local Plan over a preparation period totalling around eight years. In effect the CELPR seeks development at the same locations described in the just-adopted local plan.

At Regulation 18 stage the *storyboard/webpage* **[PP021.1]** clearly set out which of the policies highlighted at the scoping stage in Autumn 2020 were being reviewed at this draft stage (having progressed from the Scoping Stage) with a link to polices which have been considered as part of the review of the *DPDs*

[PP002.1] which detailed all of these, along with the proposed change and how the policy will subsequently achieve better outcomes for climate change. In addition to this the policy changes were set out within the DPDs themselves (*Part One* **[PP001]** and *Part Two* **[PP002]**) and illustrated through a colour coded tracked changes style of approach. Red strike through text indicated text to be deleted and blue text indicated new text that has been added.

A series of topic papers were also produced following the scoping consultation which outlined the outcomes of the scoping stage consultation (sept – Nov 2020). These were:

- **[TP_01]** Topic Paper 1: Water management consideration of alternative approaches
- **[TP_02]** Topic Paper2: Green Blue Infrastructure consideration of alternative approaches
- **[TP_03]** Topic Paper3: Strategic transport consideration of alternative approaches
- **[TP_04]** *Topic Paper4: Heritage and climate change consideration of alternative approaches*
- **[TP_05]** *Topic Paper5: Energy efficiency* & *renewable energy consideration of alternative approaches*
- **[TP_06]** Topic Paper 6: Miscellaneous policies consideration of alternative approaches

Within these topic papers, the policies that were considered for potential amendment at scoping stage were set out again, with information on the issues raised by respondents to the consultation as well as *SA* **[P_03]** and *HRA* **[P_04]** input, leading into how the policy would be amended in the Regulation 18 draft version of the CELPR. Again, the scope of the CELPR continued to be made clear throughout the plan production process with the focus not deviating away from the initial 32 policies presented at the scoping stage (as shown in Table 1 and Table 2 above).

In addition to this, a series of videos were produced at this Regulation 18 stage which set out the overall approach to the review (which once again reiterated that the review was a partial review focusing on climate change matters only) as well as 5 topic-based videos which clearly explained the proposed policy changes in relation to the defined topic. These were:

- **PP021.2:** Introduction to Regulation 18 Consultation <u>Video</u>
- **PP021.3:** Addressing Heritage <u>Video</u>
- **PP021.4:** Addressing Transport <u>Video</u>
- PP021.5: Addressing Green and Blue Spaces Video
- **PP021.6:** Addressing Sustainable Design, Energy Efficiency & Renewable Energy <u>Video</u>
- **PP021.7:** Addressing Water Management <u>video</u>

• REGULATION 19 STAGE (January – March 2022)

A *Guide to Making a Representation* note for representors **[P_11]** was produced and made available on the website as well as a *Statement of Representation* procedure **[P_09]** and the *FAQ* document **[P_M04]**, see specifically section 7 on page 4 of this document where once again the scope of the CELPR that has been determined is made clear to representors. Paragraph 7.4 in particular describes the process that the council took in identifying the policies for review and moving these forward through the Topic Papers and subsequently policy amendments.

The representations that were received as part of the Regulation 18 consultation held July-Sept 2021 were set out at this '*A Summary of the Regulation 18 Representations'* **[P_27]**. Within this the council set out if reps received were outside of the scope of the CELPR and also if a follow action was needed.

A report to Lancaster City Council's Cabinet <u>on 18th January 2022</u> made clear at section 3.1 that the scope of the partial review had been considered during late 2020 and that at this stage the council were publishing the CELPR to allow stakeholder and the wider community to comment on the soundness of the published CELPR.

For the purposes of clarity, the council can confirm that all representations received within the defined consultation timeframes have been accepted as Duly Made by the council, even where these related to policies not subject to the Climate Emergency Review (see policies set out at table 6 and 7 of this document for a list of these).
