1.0 Title of the Proposed Development Plan Documents (DPD)

- 1.1 Lancaster City Council has prepared a Climate Emergency partial review of its Strategic Policies & Land Allocations Development Plan Document (DPD) and the Development Management DPD. These represent the two key elements of the new Local Plan for Lancaster District, which it proposes to submit to the Secretary of State under Regulation 22 of the Town and County Planning (Local Planning) (England) Regulations 2012.
- 1.2 The Publication versions of the review of the Strategic Policies & Land Allocations DPD and the Development Management DPD are being made available for a 6 week period from Monday 31 January 2022 to 12noon Monday 14 March 2022 prior to being submitted to the Secretary of State. Alongside these Publication documents, the Sustainability Appraisal (SA) Report, Habitats Regulation Assessment (HRA), Equalities Impact Assessment (EqIA), Health Impact Assessment (rHIA) and a wide range of other supporting evidence will also be made available to inform any representations on the Published DPDs.

2.0 Proposed Subject Matter and Area Covered

- 2.1 The council is reviewing the Strategic Policies & Land Allocations DPD, which was adopted in July 2020. This DPD sets out the strategic basis for planmaking within Lancaster District up to 2031, it sets out the scale of growth required and how that growth will be delivered. The DPD sets out a range of allocations which address the delivery of new development and the protection of land for its environmental, economic or social value. The DPD is applicable to all areas of the district, however is supplemented in specific areas by more bespoke Development Plan Documents, this includes the Arnside & Silverdale AONB DPD and the Morecambe Area Action Plan DPD.
- 2.2 The council is also reviewing the Development Management DPD, which was originally adopted in December 2014, reviewed and adopted in July 2020.

The council is taking this opportunity to review elements of the original DPDs to considered improved climate change policies.

2.3 Upon adoption, the Strategic Policies & Land Allocations DPD and the Development Management DPD will form the Strategic Plan for Lancaster District, replacing any remaining policy contained within the existing Lancaster District Local Plan, which was formally adopted by the council in July 2020.

4.1 The statutory period for making representations in relation to 'legal compliance' and/or 'soundness' of the Strategic Policies & Land Allocations DPD and/or the Development Management DPD is for a period of 6 weeks starting from Monday 31 January 2022 to 12noon Monday 14 March 2022.

PLEASE NOTE: Late representations will not be accepted.

4.2 During this formal Publication period you will only be able to comment on whether you find the Strategic Policies & Land Allocations DPD and/or the Development Management DPD to be sound (compliant with National planning policy) and compliant with legal requirements. Only those representations that are made in writing (either electronically or on paper) and arrive at the address specified within the 6 week consultation period closing at 12 noon on Monday 14 March 2022 will be considered alongside the submitted Strategic Policies & Land Allocations DPD and the Development Management DPD, which will both be examined by an independent Planning Inspector.
- 5.5 It is strongly recommended that you make use of the formal representation forms, which have been provided by the council to make your representation to ensure that it relates to the issues of legal compliance and/or soundness. Any individual submitting a representation that is not in a format which is consistent with the representation form may be required to re-submit their representation in the appropriate format.

PLEASE NOTE: Late representations will not be accepted after 12 noon 14 March 2022

5.6 Comments that have been received during previous consultation exercises will not be carried forward into the Publication Stage.

- The Adoption of the Strategic Policies & Land Allocations DPD and the Development Management DPD.
