Notice is hereby given that Lancaster City Council, having consulted Lancashire County Council and the Chief Officer of Police, and in exercise of its powers under sections 32, 33, 34 35, 35, 39, 124 and Schedule 9 of the Road Traffic Regulation Act 1984, and with consent of Lancashire County Council have made the City Council of Lancaster (Off Street Parking Places) (Consolidation) Order 2023.

The effect of the City Council of Lancaster (Off Street Parking Places) (Consolidation) Order 2023 is to (1) Consolidate the City Council of Lancaster (Off Street Parking Places) Order 2020 and sequence amendments (2) amend the City Council of Lancaster (Off Street Parking Places) Order 2020 fees and charges, (3) Amend the Battery Breakwater Morecambe boundary sketch (plan 18) to include the Cocklers area, (4) To amend the Central Drive Morecambe boundary sketch (plan 31), (4) To add Castle Grove (Jubilee Court) permit only car park into the Order (plan 32), (5) To add electric vehicle recharging per kWh charging tariff into the Order, (6) To add Lansil car park into the Order (plan 33), (7) Permit classes amendments.
