**(OFF STREET PARKING PLACES) (Consolidation) ORDER 2023**

**(AMENDMENT NO 1) ORDER 2024**

The City Council of Lancaster (hereinafter referred to as "the Council") pursuant to arrangements made under section 101 of the Local Government Act, 1972 with the County Council of Lancashire in exercise of its powers under Sections 1, 2, 32, 33, 34, 35, 35C, and Schedule 9 of the Road Traffic Regulation Act 1984(hereinafter called the "1984 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and Section 43 and Schedules 3 and 6 to the Road Traffic Act 1991(hereinafter called the "1991 Act") hereby make the following order.

1. Commencement, Citation and Revocation

1.1 This Order shall come into operation on [insert date] and may be cited as " THE CITY COUNCIL OF LANCASTER (OFF STREET PARKING PLACES) (Consolidation) ORDER 2023 (AMENDMENT NO 1) ORDER 2024".

2. Interpretations

2.1 Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

2.2 In this order, except where the context otherwise, requires, the following expressions have the meanings hereby respectively assigned to them: -

2.2.1 "1984 Act" means the Road Traffic Regulation Act 1984 as amended by the Road Traffic Act 1991.

2.2.2 "Enactment" - means any enactment, whether public, general, or local and includes any order, bylaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

2.3 Any reference in this order to any enactment shall be construed as a reference to that enactment as amended or substituted by any subsequent enactment.

2.4 Any reference in this order to a masculine gender shall include reference to the feminine gender and neuter gender.

2.5 Any reference in this Order to a singular includes the plural.

2.6 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. Amendments

3.1 THE CITY COUNCIL OF LANCASTER (OFF STREET PARKING PLACES) (Consolidation) ORDER 2023, the Principal Order is hereby amended as follows:

(1) Under "Part A" of the Principal Order in the relevant place add "Resident Parking Permit" means a Permit issued by the Council under the Provisions of Part F.

- (2) Part F is amended as follows:
  - (a) A new header is added titled “**Resident’s Parking Permit**” immediately below insert Article 37A “Residents of a particular address, as determined at the absolute discretion of the Council, are entitled to purchase a Resident Parking Permit in accordance with the charges in Table 2 of the First Schedule. Residents who apply are required to provide proof of residence. Such a permit may be issued by the Council on such terms and conditions and to such residents as the Council may at its discretion decide, permitting the holder to park in such Parking Place as has been specified in the granting of the permit and in the First Schedule.
- (3) The Scale of Charges and Permit Charges as detailed in the First Schedule to the Principal Order be amended as set out in the attached Amendment No 1 First Schedule 2024 (Annex 1)
- (4) The First Schedule to the Principal Order be amended to include new car parks known as “Wheatfield Court”, “Middle Street” and “Kingsway” and identified by reference to the plan as stated and attached (Annex 2). The car parks to be subject to the restrictions as set out in the attached Amendment No 1 First Schedule 2024 (Annex 1)
- (5) Plan 31 Central Drive, Morecambe is amended and replaced with the attached Plan 31 attached (Annex 2)
- (6) Friars Passage car park is removed from the First Schedule to the Principal Order

The First Schedule to the Principal Order is hereby amended by the attached Amendment No 1 First Schedule 2024

The Prohibitions and Restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
