- 4. The £500 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom.
- 5. If the election is contested the poll will take place on **THURSDAY 4 JULY 2024**.

New applications to vote by post, and amendments or cancellations of existing postal vote or proxy vote arrangements must reach the Electoral Registration Officer at the Town Hall, Lancaster, LA1 1PJ by 5.00PM ON WEDNESDAY 19 JUNE 2024. - Applications to vote by proxy at this election must reach the Electoral Registration Officer at the Town Hall, Lancaster, LA1 1PJ by 5.00PM ON WEDNESDAY 26 JUNE 2024. Applications can be made online in certain circumstances: <u>https://www.gov.uk/apply-proxy-vote</u>
- Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer at the Town Hall, Lancaster, LA1 1PJ by 5.00 p.m. on Wednesday 26 June 2024. - 10. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the Town Hall, Lancaster, LA1 1PJ by 5.00PM ON THURSDAY 4 JULY 2024. The physical incapacity must have occurred after 5.00PM ON WEDNESDAY 26 JUNE 2024. To apply on the grounds of work/service, the person must have become aware after 5.00PM ON WEDNESDAY 26 JUNE 2024 that they cannot go to the polling station in person.
