

**LANCASTER CITY COUNCIL**  
**THE CITY COUNCIL OF LANCASTER (OFF STREET PARKING PLACES) (CONSOLIDATION) ORDER 2023**  
**AMENDMENT NO. 3 ORDER 2025**

Notice is hereby given that Lancaster City Council, subject to approval of Lancashire County Council and the Chief Officer of Police, and in exercise of its powers under sections 32, 33, 34 35, 35 (c), 39, 124 and Schedule 9 of the Road Traffic Regulation Act 1984, proposes to amend The City of Lancaster (Off-Street Parking Places (Consolidation) Order 2023.

The effect of the Amendment No. 3 Order of 2025 is to (1) add a new car park to be known as Moor Mills 4, associated plan (plan36), conditions of use, charges and permit arrangements (2) add a new car park to be known as Edward Street 2, associated plan (plan37), conditions of use, charges and permit arrangements (3) amend plan 23 (Kingsway) to extend the car park area (5) Amend plan 17 Old Station Morecambe and create a 40 minutes 3 hour no return loading bay restriction highlighted in the blue box. The proposed changes to fees and charges are set out below: -
