

**LANCASTER CITY COUNCIL**  
**THE CITY COUNCIL OF LANCASTER (OFF STREET PARKING PLACES 2019)**

Notice is hereby given that Lancaster City Council, having consulted Lancashire County Council and the Chief Officer of Police, and in exercise of its powers under sections 32, 33, 34 35, 35 (c), 39, 124 and Schedule 9 of the Road Traffic Regulation Act 1984, propose to create the City Council of Lancaster (Off-Street Parking Places) Order 2019.

The effect of the Order of 2019 is to (1) add the new car parks to the City Council of Lancaster (Off-Street Parking Places) 2019 Order's Schedule of car parks; (2) To extend the City Council of Lancaster (Off Street Parking Places) Order 2019 to include electric vehicle charge point enforcement; (3) To amalgamate the car parks within the proposed Canal Quarter area.; (4) to make reference in the Schedule to car park plans, a list of permit charges and categories of scales of charges. The new car parks, its scale of charges and other car park changes are as follows:

Anyone wishing to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or the powers conferred by the Traffic Management Act 2004, or on the grounds that any requirement of the Acts, or any instrument made under them, has not been complied with in relation to the Order may, within 6 weeks from the date of this Notice, apply to the High Court for this purpose.
